CCN provides primarily hourly services to its customers and has an outstanding reputation for high quality care in its markets. The original founder of the business, Susan Rodgers, turned day-to-day operations over to her son, Brian, seven years ago. Under Mr. Rodgers leadership, CCN has experienced strong and consistent growth throughout the past decade.
